## Call for Entries **Figures, Forms & Faces** Art Exhibition

An open art exhibition will be held at  
the **Kimberley Arts at Centre 64** from **Jan. 02 – Jan. 27, 2018**.  
The title and theme of the exhibition is **Figures, Forms & Faces**.

***This exhibit of artworks can be loosely interpreted involving portraits and/or figurative sketches, drawings, paintings, shapes and sculptures.***

Artworks in any medium will be accepted.

Artists may enter a **maximum of 3** pieces appropriately framed or mounted for exhibition. There will be **no hanging fee for members of the Kimberley Arts Council-Centre 64**. Non-members will be required to pay a fee of \$25.

**The deadline for entries is December 23, 2017**. Please complete this entry form and return it to Kimberley Arts Council-Centre 64 together with the appropriate entry fee. Artworks should be **delivered** to Centre 64 between 1pm and 5pm on or before **December 23, 2017**.

A **public reception** will be held for the **Figures, Forms & Faces** open exhibition from **2pm to 4pm on Saturday, January 6, 2018**. Invitations for artists to send out to guests may be picked up from Centre 64 when submitting entries.

### **ENTRY FORM**

*To be accepted for exhibition all hanging artworks must be equipped with proper hanging hardware and must be appropriately mounted and framed for display. Three dimensional pieces must come with any required supporting equipment. The gallery committee reserves the right to reject submitted artworks not considered to be of sufficiently high technical standard or to be inadequately presented for this exhibition.*

*Exhibiting artists are responsible for insuring their artworks while on exhibition at Kimberley Arts at Centre 64. Kimberley Arts Council – Centre 64 cannot be responsible for loss of or damage to artworks while on exhibition at Centre 64.*

*A 30% commission will be charged by Kimberley Arts Council – Centre 64 on all artworks sold while on display in the Art of Dance open art exhibition.*

*Following the exhibition, artworks should be **picked up** from Kimberley Arts at Centre 64 after 4 pm on Saturday, January 27, 2018 or by arrangement with the administrator at Centre 64.*

I, the undersigned, agree not to hold the Kimberley Arts Council-Centre 64 Society or the City of Kimberley or any of their members, staff or volunteers legally liable for any damage, loss or injury to persons or property sustained by accident or incident in or about the Centre 64 premises. Further, I waive any claim I may have with respect to any loss of damage or injury to my property.

I am responsible for the insurance coverage for all my pieces of work from the time they are delivered to Centre 64 until the time they are removed from Centre 64.
